



2024 MEMBERSHIP OPTIONS

Unlimited

Allows the designated Member (or couple) unlimited golf play seven days per week. Tee times may be made up to 14 days in advance.

Weekday Plus

Allows the designated Member (or couple) unlimited golf play Monday through Thursday and after 1pm Friday through Sunday. In addition, Member (or couple) may use this Membership for all Men's and Ladies' Club events. Tee times may be made up to 14 days in advance.

Weekday

Allows the designated Member (or couple) unlimited golf play Monday through Thursday only. Tee times may be made up to 14 days in advance.

Junior Add-On

Allows the designated Member to add a son or daughter under 21 years of age to a Membership.

Power Cart Option

Allows the designated Member (or couple) unlimited power cart access while playing golf.

2024 APPLE TREE GOLF COURSE MEMBERSHIP AGREEMENT

- 1. General Understanding.** The undersigned understands the information in the agreement concerning Membership at the Apple Tree Golf Course and hereby agrees to the Membership benefits, dues schedule and Rules and Regulations provided. The undersigned further acknowledges that the golf course and other facilities are open to the public and host daily fee golfers, as well as corporate and charity outings on a regular basis. Because of this, the golf course may not be available each time the undersigned chooses to play.
- 2. 12-Month Membership.** The undersigned understands and acknowledges that the Apple Tree Golf Membership program is a 12-month annual program with dues payments on a monthly basis from April 1, 2024 through March 31, 2025. While the membership typically runs from April 1, 2024 through March 31, 2025, if a Member joins any time after April 1, the Membership shall run from the date of sign-up through March 31, 2025. ***Regardless of when a Member joins, Members will be required to make monthly Membership payments through March 31, 2025 with no cancellation option.*** The only exceptions to the no cancellation policy include death, major surgery or injury (with note from a Physician), or when a Member moves to another state (with proof required). In the event of an approved cancellation, a 1-month penalty will be charged for breaking the agreement.
- 3. Charging of Membership Dues.** Members will be required to have a valid credit card on file. Upon registering for an Apple Tree Golf Membership, the first month's dues will be charged upon registration. For all subsequent months, dues and all applicable charges for each month will be charged to the card on file on the 10th day of the following month. The undersigned agrees that all disputes on the credit card account relating to Apple Tree will be promptly brought to Apple Tree's attention.
- 4. Delinquent Memberships.** If the Member account of any member is delinquent, Apple Tree may at its option take whatever action it deems necessary to effect collection, including without limitation, suspension or termination of a membership or legal action. When a member is 30 days delinquent and the card on file is unable to be charged, he/she will be notified by letter. Charging privileges may be suspended and designated as "Cash Only" until the account is paid in full. When a member is 60 days or more delinquent and the card on file is unable to be charged, Apple Tree will suspend the member until the account is paid in full. A service charge equal to 5% of the entire unpaid balance shall be charged to the members account at the end of each consecutive month they are delinquent. If Apple Tree commences any legal action to collect any amount owed by any member or to enforce any other liability of any member, and if judgment is obtained by Apple Tree, the member shall also be liable for all costs and expenses of such legal action and reasonable attorneys' fees, including any fees required in connection with appellate proceedings.
- 5. Receipt of Membership Plan and Information.** The undersigned hereby acknowledges receipt of The Apple Tree Golf Course Membership Information and these exclusions and limitations and have read and understand them, and agree to be bound by the terms and conditions thereof as the same may be amended from time to time by Apple Tree. The undersigned further acknowledges that he/she is not relying on any oral representations in acquiring a membership at Apple Tree.
- 6. Membership Privileges.** The undersigned understands that Members are allowed to use the Apple Tree Golf Course and practice areas during operating hours only. Members ***DO NOT*** have use privileges to other Apple Tree facilities including but not limited to Apple Tree Clubhouse Banquet Facilities, Apple Tree's Braeburn Park (Swimming Pool, Hot Tub, Sport Court, Playground), and Apple Tree's Clubhouse Park (Swimming Pool, Hot Tub, Pickleball Courts) at this time. By obtaining a membership at Apple Tree, Members obtain a non-exclusive revocable license to use the golf facilities in accordance with the

classification of membership selected by the Member. Members do not obtain any equity or ownership interest at Apple Tree or the facilities provided at Apple Tree Golf Course, do not have and do not acquire any property rights or other interest in any property at Apple Tree, do not have any rights to become involved in the management or operation of the facilities provided at Apple Tree Golf Course and are not subject to any assessments for operating deficits incurred in the operation of the facilities provided at Apple Tree Golf Course or any assessments for capital improvements to the facilities.

7. **Modification and Termination of the Membership Plan.** The undersigned understands that Apple Tree reserves the right to amend and modify this Membership program in any manner it deems appropriate, in its sole discretion. All Members agree to be bound by any changes to this Membership.

8. **Indemnification and Assumption of Risk.** By executing the Application for Membership Privileges and the Membership Agreement, Applicant hereby agrees to indemnify, defend and hold Apple Tree Golf Course and its affiliated entities (and their respective owners, directors, partners, officers, operators, employees and other agents) harmless from and against any and all liabilities, costs (including reasonable attorney's fees), claims, demands or damages incident to or arising out of or relating to the acts or omissions of Applicant, their Family or guest(s), and their respective use or occupancy of the Facilities. In addition, by executing this Agreement, Applicant hereby voluntarily assumes all risks of accident or damage to Applicant's person or property, and the person or property of Applicant's Family and guests, arising out of or relating to the use or occupancy of the Facilities including but not limited to errant golf balls, operation of a golf cart, and adverse weather conditions including lightning.

9. **Booking Tee Times.** Members may reserve tee times up to 30 days in advance via appletreeresort.com, the Apple Tree Golf Course App, or by calling the Apple Tree Pro Shop. Individual members may make reservations for up to 4 players, however, there will be a \$35 no show fee charged to the member for each unfilled slot. The purpose of this policy (both for the public and for members) is to prevent overbooking of tee times that go unused.

10. **Late Check-In, No-Show, Overbooking and Cancellations.** Failure to check-in 10 minutes prior to your scheduled tee time may result in loss of tee time and or no-show fee charges. Members wishing to cancel a tee time must do so at least 24 hours in advance to avoid no-show fees and loss of booking. Cancellation of the ability to book advance tee times and/or membership suspension will be considered in the event of repeated no shows.

11. **Power Golf Cart Policy.** By signing below, I acknowledge and accept the responsibility for the safe and proper operation of Apple Tree Golf Carts (if applicable). I acknowledge that I am liable for all medical and legal claims that may arise from my use of a golf cart. Furthermore, I hereby authorize Apple Tree Golf Course to charge my credit card on file for any expenses incurred to repair damage caused while the golf cart was in my possession.
